

WHAT IS COMIKET?

COMIKET IS A SERVICE PROVIDED BY SMASH! TO HELP ARTISTS EXHIBIT, SELL AND SHOWCASE THEIR WORK without having to physically be at SMASH! or have a table in the Artist Circle. Instead, SMASH! will display and sell artwork on behalf of artists for a 20% commission fee on sales.

WHO CAN APPLY?

Any artists who are having difficulty obtaining an artist table at SMASH!, whether due to budget concerns, limited availability, geographical concerns, scheduling conflict, or any other reason. If you have artistic creations to sell, we'll be happy to showcase them for you.

TERMS AND CONDITIONS

1. Maximum product range: 3 items
2. Size restrictions: No larger than A3 and no smaller than A6.
3. Maximum quantity per item: 20
4. SMASH! will be responsible for any goods that are lost or stolen at the Comiket table during the convention.
5. To avoid any complications and ensure your package reaches us in time, please send your package **at least** one week before the convention. It is the responsibility of the applicant to make sure any damage incurred by shipping or handling is reduced to a minimum. SMASH! will not be responsible for any damage caused during shipping, handling, or trading.
6. Due to limited space, your work may not be displayed on the table at all times.
7. Any remaining goods will be shipped to their owners within one month after the convention. SMASH! does not cover the shipping fee to return your goods. Please include the shipping fee in the parcel along with your goods, or SMASH! will deduct the shipping fee from your sales. SMASH! reserves the right to retain your goods if applicants fail to provide for necessary shipping costs.
8. The rules regarding exposure of inappropriate content at the Artist Circle also apply to Comiket.

HOW TO APPLY AND DELIVERY PROCEDURE

VIA PARCEL

SMASH! 2008 COMIKET TERMS AND CONDITIONS

This document is a contract between SMASH Inc (herein 'SMASH!') and the signatory (herein 'the applicant'). SMASH! requires all applicants doing business at the Sydney Manga and Anime Show (herein 'the convention') to agree to and abide by the following rules and regulations. Failure to follow these rules and regulations may result in the removal of your goods from the convention.

1. SALE AND DISPLAY

- 1.1 SMASH! will display and sell artwork on behalf of the applicant for a 20% commission fee on sales.
- 1.2 The Comiket allows for a maximum of 3 unique products per applicant, these items being no larger than A3 and no smaller than A6. The maximum quantity per item is 20.
- 1.3 While SMASH will try to accommodate the goods of all Comiket applicants, due to limited space your work may not be displayed on the table at all times.

2. RETURN OF GOODS

- 2.1 Any remaining goods will be shipped to their owners within one month after the convention. SMASH! does not cover the shipping fee to return your goods. Please include the shipping fee in the parcel along with your goods, or SMASH! will deduct the shipping fee from your sales. SMASH reserves the right to retain your goods if applicants fail to provide for necessary shipping costs.

3. LOST, STOLEN OR DAMAGED GOODS

- 3.1 SMASH! will assume responsibility for any goods that are lost or stolen at the Comiket table during the convention. However, SMASH will not be responsible for any damage caused during shipping, handling, or trading. It is the responsibility of the applicant to make sure any damage incurred by shipping or handling is reduced to a minimum.

4. UNAUTHORISED ITEMS

- 4.1 The Comiket is only for the sale of originally produced works and will not engage in the sale of commercial or other products which have not been produced by you. Any persons submitting such items at the Comiket will be refused, and their items will not be put out for sale or display.

5. CONTENT RESTRICTIONS

- 5.1 Content on public display at SMASH must not breach these guidelines, and any goods which are deemed unsuitable will not be put out for display or sale at the Comiket. If you are at all unsure of any of these guidelines, do not hesitate to ask convention staff for clarification. Restricted content includes:
 - Frontal and tastless nudity, pornography, sexually orientated violence, explicit or suggestive material.
 - Material that promotes or encourages behaviour that is threatening, embarrassing, hateful, libelous, racially or ethnically insulting, or otherwise inappropriate for persons under the age of 15.
 - Extreme violence or gore

6. AGREEMENT

- 6.1 By signing this contract, the applicant agrees to the conditions set out above. SMASH! will do its utmost to ensure that the event will be an enjoyable and productive event for all concerned.
